Their salaries shall not be drawn by the concerned Drawing & Disbursing Officers till receipt of verification of their antecedents from competent authority to whom a reference shall be made by this Department. The seniority of the appointees shall be fixed in the order as per the selection list furnished by the J&K Service Selection Board and in accordance with the CCA Rules 1956.

The appointees shall be allowed to join only after production of following certificates in original.
