Subject:- Regularization of services of Shri Farooq Ahmad Wani S/O Late Habib Ullah Wani R/O Batpora Sopore and Shri Abdul Hamid Sheikh S/O Shri Ali Mohammad Sheikh R/O Kachgari Masjid Srinagar.

ORDER NO. 464 -DHPM OF 2017

Whereas Shri Farooq Ahmad Wani S/o Late Habib Ullah Wani R/O Batpora Sopore was Engaged as Runner in KFF Sopore by the AGMO I/C KFF Sopore vide No. KFF/SOP/1999-91/01 dated 12.09.1990 and Shri Abdul Hamid Sheikh S/O Shri Ali Mohammad Sheikh R/O Kachgari Masjid Srinagar was engaged as Attendant in KFF centre Parimpora Srinagar by AGMO / I/C KFF Parimpora Srinagar vide No. 1- KFF/1992-93/172 dated 16.10.1992.

Whereas Sh. Farooq Ahmad Wani & Sh. Abdul Hamid continued to perform watch & Ward duties of Fruit & Vegetable Market Sopore in pursuance to approval conveyed by Administrative Department vide No.Agri/HPM/379/79 dated 18.10.1994 as casual labour.

Whereas due to stoppage of allocation under wages component by the Government, the wages of the casual labours are presently being met out of the resources of APMC Sopore in pursuance to order's of J&K High Court Srinagar & approval conveyed by Administrative Department vide No.Agri/HPM/45/2010 dated 27.10.2011.

Whereas the case for regularization of above two casual labours was submitted to the Administrative Department vide No.DHPM/101/2013-14/5459 dated 10.01.2014.

Whereas Sh. Farooq Ahmad Wani & Sh. Abdul Hamid Sheikh preferred a writ petition SWP No. 1241/2010 titled Abdul Hamid Sheikh & others v/s State & others before the Hon'ble High Court of J&K at Srinagar for regularization of their services.

Whereas the Hon'ble High Court of J&K at Srinagar while allowing the writ petition issued an order dated 20.04.2017. The operative part of which reads as under.

"For the reasons mentioned above, petition is allowed and the respondents are directed to consider the case of the petitioners for regularization within stipulated timeframe preferably within two months from the date of receipt of the copy of this order".

Whereas the matter was again taken up with Administrative Department vide No. DHPM/Lit/2017/2826 dated 14.09.2017

Whereas the Administrative Department has vide No.Horti/27/Legal/2017 dated 27.11.2017 conveyed its approval for consideration of the petitioners namely Sh. Farooq Ahmad Wani & Sh. Abdul Hamid Sheikh against the Class-IV vacancies on the analogy of

Sh. Fakrudin & Sh. Kishori Lal Singh subject to fulfillment of conditions prescribed under SRO 64 dated 24.03.1994.

Now therefore in compliance of the directions of the Hon'ble High Court of J&K vide Order dated 20.04.2017 in the case SWP No. 1241/2010 titled Abdul Hamid Sheikh & others v/s State & others and pursuant to approval conveyed by Administrative Department vide No. Horti/27Legal/2017 dated 27.11.2017, the services of Sh. Farooq Ahmad Wani S/O Late Sh. Habib Ullah Wani R/O Batpora Sopore & Sh. Abdul Hamid Sheikh S/o Ali Mohammad sheikh R/O Kachgari Masjid Srinagar are hereby regularized in the pay band of Rs.4440-7440 with grade pay of Rs.1300/- with immediate effect against available vacancies of Orderly / Chowkidar in the Department.

The posting of above Class-IV employees are ordered as under.

1. Shri Farooq Ahmad Wani Orderly / Chowkidar shall continue to work for watch and ward of Area Marketing Office Sopore.
2. Shri Abdul Hamid Sheikh, Orderly / Chowkidar shall report in the Office of newly established Assistant Grading & Marketing Officer Kruhan Managam Baramulla for further duties.
