Whereas Mr. Gulrez Malik S/o Mr. Mohd. Sadiq Malik R/o Nagar Badherwah and Mr. Jashkaran Singh S/o Mr. Yeshpal Singh R/o Hanji Khanka Nowshera Rajouri were appointed as Grading / Marketing Inspectors in the Department of Horticulture Planning & Marketing under Open merit and ALC categories respectively vide Order No. 386-DHPM of 2018 dated 15.10.2018 as per recommendations of J&K Service Selection Board vide letter No. 55B / Sel / Secy / 2018 / 9090-96 dated 31.07.2018.


Whereas they were directed to report Directorate of Horticulture Planning & Marketing within a period of 21 days from the date of issuance of the appointment orders in their favour with a further direction that in case they fail to join within the stipulated time of 21 days their appointment shall be deemed as cancelled abinitio, without any further notice.

Whereas they did not report to this Directorate within the stipulated period nor have made any correspondence with regard to their joining with this Directorate.

Whereas they were still served a final notice at the expiry of initial 21 days vide this Office letter No. DHPM/101/Esttb/2018/5058-59 dated 12.11.2018 to report to this Office for duties within a period of seven days from the date of issuance of Notice (to rule out exigencies, if any,) failing which their appointment order shall be deemed to have been cancelled.

Whereas they have not reported to this Directorate for duties even after the final notice served upon them.

Now therefore their appointment order as Grading / Marketing Inspectors in the Department of Horticulture Planning & Marketing issued in their favour vide Order No. 386-DHPM of 2018 dated 15.10.2018 is hereby cancelled with immediate effect.
