In continuation to the Order issued by this Directorate vide No.360-DHPM of 2017 dated 10.11.2017 and Order issued vide No. 363-DHPM of 2017 dated 13.11.2017 sanction is hereby accorded to the appointment of Mr. Jatinder Nath S/o Jagdish Nath R/o Nagar Badherwah Doda as Grading / Marketing Inspector (State Cadre) in the pay band of Rs.9300-34800 with Grade pay Rs.4200/- under "SC category" against available vacancy in the Department of Horticulture (Planning & Marketing) with immediate effect.

The appointee shall report to the Directorate of Horticulture Planning & Marketing Narwal Jammu within a period of 21 days from the date of issuance of this order. In case of failure of the appointee to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.

Pending verification of character and antecedents of appointee by the competent authority, appointee shall be allowed to join on his own risk and responsibility. Appointee shall have to submit an undertaking in the shape of an affidavit to the effect that in case any adverse remarks is found / reported against him, he shall have no claim for the post of Grading / Marketing Inspector and the appointment shall be cancelled abinitio and also in case the certificates produced by the appointee are proved fake / forged, the appointment shall be cancelled abinitio. The salary shall not be drawn by the concerned Drawing & Disbursing Officer till receipt of verification of his antecedents from competent authority to whom a reference shall be made by this Department. The seniority of the appointee shall remain intact with as per the selection list furnished by the J&K Service Selection Board and in accordance with the CCA Rules 1956.

The appointee shall be allowed to join only after production of following certificates in original.

1. Date of Birth certificate
2. Academic Qualification Certificate
3. No Loan certificate from DIC / Employment Department.
4. Medical certificate
5. State Subject Certificate.
6. Verification of character and antecedents from competent authority.
7. Category certificate.

The appointment of the above candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009. The appointee shall be on probation for a period of two years in terms of CCA Rules 1956.
