As recommended by the J&K Service Selection Board vide letter No.55B/Secy/Sel/2018/9090-96 dated 31.07.2018 and pursuant to the approval conveyed by the Administrative Department vide No.Agri/Coord/76/2006-IV dated 10.09.2018, sanction is hereby accorded to the appointment of following candidates as Grading / Marketing Inspectors (State Cadre) in the pay band of Rs.9300-34800 with Grade pay Rs.4200/- (pre revised) against available vacancies in Horticulture Planning & Marketing Department with immediate effect.

The appointees shall report to the Directorate of Horticulture Planning & Marketing Rajbagh Srinagar within a period of 21 days from the date of issuance of this order. In case of failure of any of the appointee to join within the stipulated period, his / her appointment shall be deemed to have been cancelled without any further notice.



Pending verification of character and antecedents of appointees by the competent authority, appointees shall be allowed to join on their own risk and responsibility. Every appointee shall have to submit an undertaking in the shape of an affidavit to the effect that in case any adverse remarks are found / reported against him, he shall have no claim for the post of Grading / Marketing Inspector and the appointment shall be cancelled abinitio and also in case the certificates produced by the appointees are proved fake / forged, the appointment shall be cancelled abinitio. Their salaries shall not be drawn by the concerned Drawing & Disbursing Officers till receipt of verification of their Character and Antecedents from competent authority to whom a reference shall be made by this Department. The seniority of the appointees shall be fixed in the order as per the selection list furnished by the J&K Service Selection Board and in accordance with the CCA Rules 1956.

The pay of the appointee shall be regulated as per SRO 202 dated 30.06.2015. The appointee shall be on probation for a period of five years. The appointees shall be allowed to join only after production of following certificates in original.

1. Date of Birth certificate
2. Academic Qualification Certificate
3. No Loan certificate from DIC / Employment Department.
4. Medical Certificate
5. State Subject Certificate.
6. Category Certificate, if any.

The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
