The Union Finance Minister announced that **"Operation Green"** will be extended to all Fruits and Vegetables. The scheme will features a 50% subsidy on transportation from surplus to deficient Markets and 50% subsidy on storages including Cold Storages.

In this regard, a committee of following officers is hereby constituted to work out various parameters and proposal thereof for different agricultural commodities particularly apple, cherry, strawberry and other crops for submission to the Ministry of Food Processing & Industries Government of India for extending the benefit of the scheme to the UT of J&K.

The above committee will submit the proposal along with feasibility report to this office by or before 9th of June 2020 positively for onward submission to the higher authorities.

1. Season of different fruits produced in J&K with production to be covered.
2. Nature of fruit commodities i.e. highly perishable, perishable and less perishable.
3. Price index during the year for different fruits and vegetables.
4. Markets from where fruits and vegetables commodities of J&K are exported / sold to other parts of India and abroad.

5. Storage facilities in J&K i.e. Cold Storage, C.A. Storages, warehouses and Scientific Warehouses.
6. Prospects of storages in non production marketing area.
7. Consumer preferences analysis (Index) during off season (demand / sales)
