Director visits Parimpora Mandi Highlights the importance of E-nam



Director Horticulture (P&M) Vishesh Mahajan today visited Fruit & Vegetable Market Parimpora where he had a detailed review of developmental activities and also interacted with the trading community.He was accompanied by officers of the department.

Director took a tour of the mandi where he gave on the spot instructions for a number of issues that were brought to his notice.

He instructed that the water logging issue should be addressed without delay and the concerned were directed to act upon issue immediately. He also instructed engineering wing of the department to take on war footing the macdemisation of mandi link roads.

He stressed upon need to have modern waste disposal mechanism in the shape of a segregation machine installed in the mandi periphery to segregate and convert the waste into compost. He also advised all the stake holders to maintain hygienic environment in the mandi.

Director visited the site of a huge Controlled Atmosphere (CA) store coming up in the mandi which according him will be of extreme help to the traders in mandi.

A number of issues were raised by the members of Fruit Association during the meeting with Director Horticulture (P&M) who assured them of speedy redressal. Director stressed upon growers and traders to enroll themselves on e-NAM portal for

their trading practices. He highlighted the benefits of trading on E-nam which he claimed is going to be the future for trading. Director Horticulture (P&M) was apprised by
